## FROM KIWANIAN BARB:

#### **Ridge Marsh Manor funds**

By deadline of August 31, 2009, I completed PIF's (Project Information Forms) for the following list of projects at Ridge Marsh Manor.

1) New fridges - 10

2) New stoves - 11

3) Vinyl flooring - in 5 apartments (to cover asbestos containing flooring) and in five areas on the common level - laundry, electrical, and janitor's rooms, plus each of the north and south end entrances

4) In-Suite sounders to improve existing fire alarm system in the building - which currently consists of one bell in each of the upper and lower building hallways.

5) Garden Doors to replace patio door - in each of the 12 units

6) New UPPER and replacement lower kitchen cupboards (complete with new countertops) in every unit

7) New METAL roof on the entire building

The program is called "SHRRP" - Social Housing Renovation & Retrofit Program - and it is 50% provincially and 50% federally funded.

In order to apply, for EACH PROJECT, I had to gather THREE estimates, so that I knew approximately what dollar amount to apply for, in order to complete the project. I also had to choose which year, of the two year program, each project could be begun and completed within. Year One projects must be started and completed between January 31, 2009 and March 31st, 2010. Year Two projects between April 1, 2010 and March 31, 2011. By the time the application and approval process was completed, essentially Year One projects must be begun and completed between late November 2009/and March 31, 2010. (That's why the first FOUR items above are our "Year One" projects!).

Chatham-Kent Social Housing had to collect ALL applications for CK, sift through them, and come up with which warranted receiving money under the program. Council then had to approve CKSH's proposed submission ~ then off to higher powers for more consideration & approval! Project criteria were to improve any or all of: energy efficiency, health and safety, or accessibility.

Total dollars applied for AND approved is \$113,850.00. (FREE MONEY!!!!)

However, project funds are distributed at very defined intervals and in specific percentages - 20% at start up - 50% during project and final 30% when project is completed. LOTS of paperwork to complete at each step!

In order to approve and release money on any project, CKSH must be provided with:

a) Either THREE quotes from suppliers (if under \$15,000.00 project)

OR

b) Submissions from competitors in response to a PUBLIC TENDER BID PROCESS - if over \$15,000.00 project

Thus, the first four items are reasonably easy.....but the three Year Two projects must be publicly tendered. I'm not really looking forward to specifying and writing the Request for Proposals (Public Tender) Package for each of projects 5, 6 and 7. I'm sure I'll be REALLY glad that CKSH has hired an Engineering Technician (Brandon Bechard) to help each housing provider with this process, and to oversee the paperwork of each project submission.

Ridge Marsh Manor's committee have chosen among quotes and I will be ordering the fridges and stoves on Monday, December 14th. (Maybe for pre-Christmas delivery?)

I'm awaiting pricing from three flooring contractors.

I'm still chasing down three prices on fire alarm equipment upgrades AND three prices from specially qualified electricians to install the new equipment.

I'm learning LOTS about contracting and construction.

Our current tenants (10 of 12 units occupied) are all aware of the news, and are excited for the improvements in and around their homes!! They have been and will hopefully continue to be very accomodating and understanding of the "uproar" in order to get these projects from the drawing board to completion.

Also, at our Annual Meeting of the Board of Directors, on December 1st, a much needed increase to the building's market rent was approved. MAXIMUM monthly rent at January 1, 2010 will become \$450.00 per month (All utilities included).

The Kiwanis Club of Ridgetown meets weekly at 6:30 pm in the basement of the Mount Zion Presbyterian Church, 59 Main St. E., Ridgetown, every Thursday, from September 1<sup>st</sup> through June 30<sup>th</sup> each year. Summer meetings are hosted by members at various local addresses.
